Your son/daughter is eligible to participate in the YouthVille Detroit- Detroit Youth Foundation Global Youth Services Day Event to be held throughout the Detroit area and the State of Michigan. This event will take place starting Saturday, April 24th at 830 a.m. and concluding Saturday at 4:30 p.m.. All participants are expected to stay for the entire event. This activity will take place under the guidance and the supervision of staff and volunteers from YouthVille Detroit- Detroit Youth Foundation. Due to the type of work involved participants must attend a safety training session, Monday, April 19th at 6:00 p.m. Participants must wear protective wear (gloves, goggles, masks) as needed and more specifically defined at the training session and in the participant contract.

Please do not bring electronic devices, ie. IPODS, Handheld video games, play stations, etc. YouthVille Detroit is not responsible for loss, stolen or broken personal property. Cell phones should be used only for emergencies during this event.

I hereby consent to participation by my son/daughter, _____ X in the described above. I understand that this event will take place away from facility grounds and that my son/daughter will be under the supervision of the YouthVille Detroit staff and volunteers on the stated dates. I consent to the conditions stated herein of this form and the method of transportation to and from the site and various locations during the duration of the event. In some circumstances youth may be transported by transportation provided by volunteers.
